#### World Bank Albania Forests

- Beneficiary: Ministry of Tourism and the Environment of the Albanian Government
- Duration: 2016 2020
- Budget:
- Role CSI: Lead Partner

- creating the digital land registry of pastures and forests, as part of the process of decentralization of cadastral management
- updating the cadastral information (properties and geometries) relating to approximately 343,000 hectares of forests and pastures (ESP-TS-ICB-8) and 912,385 hectares of forests and pastures (ESP-TS-ICB-8.2)



#### UNDP Albania: one-stop-shop service

- Beneficiary: Ministry of Interior of Albania, Municipality of Tirana, 48 Municipalities and 250 Local Administrative Units

## EU Institution-building for alignment with the Union acquis on the protection of personal data

Strengthening the institutional capacities of the Information and Data Protection Commissioner of Albania on supervision and monitoring the protection of personal data in both the public and private sector.

#### **Specific objective**

To support the **Information and Data Protection Commissioner of Albania** in further **aligning the national legislation** and specifically the **Law No. 9887/2008 "On the Protection of Personal Data"**, as amended, with Union acquis in the field of protection of personal data, as well as further developing administrative capacity of the Albanian institutions to enforce the relevant Union acquis.

Duration: 2020 – 2021 Budget: 400 000 Euro



#### EuropeAid Enhancing e-Government in North Macedonia

- Beneficiary: Ministry of Information Society and Administration and Cabinet of the Deputy Prime Minister, Republic of Macedonia


